



## EDUCATION PROGRAMS FOR JUDGES

Under the authority and direction of the Canadian Judicial Council, the National Judicial Institute has led the way in the development of a comprehensive curriculum of judicial education designed to meet the learning needs of judges throughout their career. This includes social context education that addresses difficult issues such as sexual violence.

The NJI and CIAJ (the Canadian Institute for the Administration of Justice) jointly deliver a 10 days seminar for new federally appointed judges. Depending on a judge's background and the kinds of cases they are assigned, the NJI will also recommend courses for their first three to five years on the bench.

In addition to a comprehensive review of the many duties of judges, focused programs are given to new judges on recent legal developments in Criminal Law, Family Law and Civil Law, social context courses with resources that include Aboriginal Law, Self-Represented Litigants and the Safety and Security of Women - a program offered jointly with the Canadian Chapter of the International Association of Women Judges Judicial education in Canada.

The development of program takes place with the participation of judges, lawyers, academia and community groups.

The CJC, for 2017-18, has approved the participation of over 900 judges to educational programs, in addition to the training given to newly appointed judges. Programs delivered last year or to be available in the coming two years include those listed below. In addition, a number of court-based programs which are customized training offered to each court are delivered throughout the year.
